Independent Special Interlocutor on Missing Children and Unmarked Burials Seeks Intervenor Status

The Independent Special Interlocutor files an Application to Intervene in Quebec Superior Court

SIX NATIONS OF THE GRAND RIVER, September 6, 2022 – The Independent Special Interlocutor for Missing Children and Unmarked Graves and Burial Sites Associated with Indian Residential Schools has filed an application with the Quebec Superior Court seeking intervenor status in Kahentinetha et al. v Société Québécoise des Infrastructures et al.

Special Interlocutor Murray's Mandate directs her to "identify needed measures" regarding the process of identifying, recovering, and protecting unmarked burial sites across Canada. One of the central issues to be determined by the Quebec Superior Court in this matter is whether the redevelopment plans relating to the site of the old Royal Victoria Hospital should be paused to allow for a full and proper search to determine if there are unmarked burials of Indigenous children on the grounds.

"As the Independent Special Interlocutor, I have been tasked with making recommen dations for respectful and culturally appropriate processes for the treatment of potential burials of children taken to Indian Residential Schools and other associated sites. If granted intervenor status in this matter, I hope to assist the Honourable Court in understanding the link between hospitals, universities and Indian Residential Schools, and provide some guidance on how Indigenous laws, customs and protocols can inform and guide the work ahead" explained Special Interlocutor Murray.

- Kimberly R. Murray was appointed by the Minister of Justice and Attorney General of Canada as the Independent Special Interlocutor for Missing Children and Unmarked Graves and Burial Sites associated with Indian Residential Schools in June 2022.
- The Special Interlocutor is independent and non-partisan and has a two-year mandate to deliver recommendations on a new federal framework to protect unmarked burial sites and support identification of the missing children.
- The Special Interlocutor will deliver an interim report in June 2023 and a final report in June 2024.
